### **ANTI BRIBERY AND ANTI CORRUPTION POLICY**

#### 1. Introduction:

#### 2. Policy Statement:

- Polymerlink prohibits any form of bribery, corruption, or unethical behavior in all its business
  activities, including interactions with customers, suppliers, government officials, and other
  stakeholders.
- We strictly adhere to all applicable anti-bribery and anti-corruption laws and regulations, including but not limited to the Prevention of Corruption Act, 1988, INDIA, and local anticorruption legislation in the countries where we operate.
- We do not offer, promise, give, request, or accept bribes, kickbacks, facilitation payments, or any other improper inducements, whether directly or indirectly, to or from any individual or entity, including government officials, to obtain or retain business or gain any improper advantage.
- We maintain accurate and transparent financial records that reflect all transactions and expenditures accurately and fairly, in accordance with applicable accounting standards and legal requirements.
- We require all employees, contractors, suppliers, and business partners to report any suspected instances of bribery or corruption promptly through designated reporting channels, without fear of retaliation.
- Gifts or hospitality (including meals, entertainment and business travel) received or offered should not be intended to influence or be perceived to influence a business decision taken in the interest of Polymerlink Pvt. Ltd. or a third party.
- Our employees must therefore adopt a cautious behaviour, appeal to their common sense in all circumstances and make an informed decision when they are required to offer or receive gifts and hospitality brands that must in any case remain a reasonable amount. The members of the Ethics, Compliance and Governance Department are at their disposal to help in that sense.

In the interest of transparency and to facilitate any audit or controls, any donation, gift or invitation is precisely recorded. Depending on their amount, prior internal validations must be obtained.

### 3. Responsibility

#### **Management:**

• Senior management is responsible for setting the tone from the top, providing leadership in promoting a culture of integrity and compliance, and ensuring the effective implementation and enforcement of
